- It is an institution of rural local self government
- Panchayati raj institution means three tier panchayat system e.i.
- GRAM PANCHAYAT
- PANCHAYET SAMITI
- ZILLA PARISHAD

GRAM PANCHAYAT:

Composition:

A Gram Panchayat shall consist of the Pradhan and such number of directly elected members as may be notified from time to time by the state Government and one member for every 350 population or part thereof of the Panchayat area shall be elected as a member of such panchayat.

- **TERM :**

5 Years, in the case of dissolution election would be compulsorily held within six months.

- **FUNCTIONS:**

Panchayat can function into three types :

- Compulsory function, optional function , functions thatf given by State Government

PANCHAYAT SAMITI

COMPOSITION:

A panchayat Samiti is composed of elected members of the area and the Block Development Officer , otherwise unrepresented members ,associate members and the elected members of that Panchayat , Block on the Zilla Parishad

- **FUNCTIONS :**

1. Provisions of drinking water in the villages .
2. Development and repair of rural roads .
3. Framing of rules and regulations for the markets .
4. Provisions of improved seeds and chemical fertilizers, pesticides, agricultural tools and implements.
5. Promotion of cottage industries such as handlooms, handicrafts, traditional art, and artisans etc.

ZILLA PARISHAD

COMPOSITION:

The composition of zilla parishad is as follows :

- 10-25 members elected directly by all voters falling within the area of Zilla Parishad . Approximately 50,000 voters elect one representative.
- All chairpersons of panchayat samitis falling within the area of the Zilla Parishad.
- MP's and MLA's representing the area.
- MPs and MLAs whose names are registered in any Constituency with the Zilla Parishad area.
- Women representation.
- SC/ST representation.
- OBC representation.

FUNCTIONS:

1. Guide and Coordinate the functions of panchayats and panchayat samitis.
2. Prepare plans for the development of a district .
3. Settles disputes between panchayats and panchayat samitis.
